# APPLICATION FOR POSTPONEMENT OF A HEARING

Section 49 of the Regulation of the Human Rights Tribunal, CQLR, c. C-12, r. 6

## **GENERAL INFORMATION**

The Application for Postponement of a Hearing must be submitted to the Tribunal at least 10 days before the scheduled hearing date. It will only be granted on serious grounds. The consent of the parties is not in itself sufficient for granting an application for postponement.

An application for postponement made less than 10 days before the scheduled hearing date may be granted only on exceptional grounds.

## PROCEDURE

## NOTIFICATION

You must notify your Application for Postponement of a Hearing to all the parties to the proceeding.

Notification may be made by registered mail, courier service (Purolator, Dicom, etc.) or by court bailiff.

### FILING AT THE COURT OFFICE

You must **file 5 copies** of your *Application for Postponement of a Hearing* along with the proof of its notification to the other parties at the office of the Court of Québec from the judicial district where the *Application to Institute Proceedings* was filed.

#### HOW TO FILL OUT THE FORM

- Provide all required information.
- The number beside the explanations refers to the corresponding section of the form.
- The form must be printed on one side of each page.



## DISTRICT AND FILE NUMBER

Enter the district and the file number as they appear on the Application to Institute Proceedings.



## **IDENTIFICATION OF THE PARTIES**

Enter the name and surname of every party to the proceeding as they appear on the Application to Institute Proceedings.

- CONTENT OF THE APPLICATION
- Select the appropriate designation in the introductory sentence.
- Enter the scheduled hearing date.
- Enter the reason(s) why your *Application for Postponement of a Hearing* should be granted and enclose the documents supporting your application (e.g., a medical certificate, a plane ticket, etc.).
- Sign your Application for Postponement of a Hearing.

## SWORN STATEMENT

### Enter your complete address.

You must sign the document before a person who is authorized to administer oaths (e.g., a lawyer, a Commissioner for oaths or a clerk of a court of justice).

#### NOTICE OF PRESENTATION

Enter the name, surname and address of the parties to whom you are notifying the application. Sign the *Notice of Presentation*.

## BACK

Most of the information required is automatically filled when you complete the present form. You should only need to enter your email and telephone number in the required section. You must staple the back at the end of your *Application for Postponement of a Hearing*.
