APPLICATION FOR REFERRAL TO ANOTHER JUDICIAL DISTRICT

Article 167 of the *Code of Civil Procedure*, CQLR, c. C-25.01 Section 114 of the *Charter of Human Rights and Freedoms*, CQLR, c. C-12

GENERAL INFORMATION

This application allows a party to ask for the case to be referred to another judicial district.

Section 114 of the Charter provides that the *Application to Introduce Proceedings* must be filed at the office of the Court of Québec in the judicial district where the defendant resides or has his principal business establishment.

PROCEDURE

NOTIFICATION

You must notify your Application for Referral to Another Judicial District (hereafter Application for Referral) to all the parties to the proceeding.

Notification can be made by registered mail, courier service (Purolator, Dicom, etc.) or by court bailiff.

FILING AT THE COURT OFFICE

You must file **5 copies** of your *Application for Referral* along with the proof of its notification to the other parties at the office of the Court of Québec in the judicial district where the *Application to Institute Proceedings* was filed.

HOW TO FILL OUT THE FORM

- Provide all required information.
- The number beside the explanations refers to the corresponding section of the form.
- The form must be printed on one side of each page.

DISTRICT AND FILE NUMBER

Enter the district and the file number as they appear on the Application to Institute Proceedings.

IDENTIFICATION OF THE PARTIES

Enter the name and surname of every party to the proceeding as they appear on the Application to Institute Proceedings.

3 CONTENT OF THE APPLICATION

- Indicate whether you are the plaintiff or defendant using the drop-down menu.
- Enter the district where the Application to Institute Proceedings was filed.
- Enter the district where you want the file to be referred.
- Enter the reason(s) why your Application for Referral should be granted.
- Enter the location and the date, and sign your Application for Referral.

SWORN STATEMENT

Enter your complete address.

You must sign the statement before a person authorized to administer oaths (e.g., a lawyer, a Commissioner for oaths or a clerk of a court of justice).

NOTICE OF PRESENTATION

Inter the name, surname, and address of the parties to whom you are notifying the application. Sign the *Notice of Presentation*.
